2023 LEGISLATIVE SCORECARD

A Note from Our Executive Director

Thank you for allowing us to share NDFA's 2023 Legislative Scorecard with you. To create the scorecard, we chose representative bills (including resolutions) from this past legislative session – bills that would affect our state's pro-life and pro-family laws, and which would help shape the legacy we leave for our children. The chosen bills also broadly represent our organization's mission, which is to equip North Dakotans to engage in God-honoring citizenship and advocate for policies that strengthen faith, family, and freedom.

This scorecard does not reflect North Dakota Family Alliance's support of any candidate or political party. Further, it does not measure any lawmaker's commitment to our state's citizens, their integrity, their religious beliefs, or their relationship with North Dakota Family Alliance. It simply documents how each lawmaker voted on these key bills, using publicly available data provided by the North Dakota Legislative Council.

To interpret this scorecard, you will need to know your legislative district number and/or who your respective legislators are. To quickly find this information, go to <u>ndlegis.gov</u>, click on "Find my Legislator" in the upper right corner, and then fill in the boxes and follow the prompts. This will also provide contact information for each of your district's legislators.

Please continue to hold our legislators accountable for their voting records, and please pray that they may always vote in ways that uphold your biblical values, as they make important decisions for our state.

HOW WE TABULATED THE RESULTS

A bill is typically passed by a simple majority in the House (48 votes out of 94 Representatives) and the Senate (24 votes out of 47 Senators). Bills under reconsideration after a veto require a 2/3 majority to override the veto, as do bills with emergency clauses.

Lawmakers earned grades ranging from 0% to 100%, based upon dividing the candidate's number of good votes by the number of total bills they voted on. The higher the percentage, the better their ranking. Scorecard ratings are based upon a bill's final vote taken in each chamber (e.g., could be a reconsideration vote to overturn the Governor's veto).

Not all lawmakers voted on every bill. The number of absences on these key votes are noted but did not count against legislators' scores. Nevertheless, we encourage you to review whether your legislators actually voted on these important bills.



HB 1176

Tax Credits in Support of Families with Children -**SUPPORTED**

Provided an income tax credit for adoptions and for contributions to a maternity home, child-placing agency, or pregnancy help center.

HCR 3002

Authorizing Sports Betting - OPPOSED

Allowed sports betting to be placed on the ballot for the 2024 general election. This resolution was defeated in the Senate.

HB 1532

Educational Reimbursement Program – SUPPORTED

Reimbursed private schools for tuition costs currently paid by parents enrolling their children in these schools. This bill was vetoed by the Governor and the House vote to override the veto failed.

HB 1205

Prohibition of Explicit Sexual Material in Public Libraries – SUPPORTED

Prohibited public libraries from maintaining books in the children's section that contain explicit sexual material. It also required that a library must develop a policy to screen for and periodically review book collections for explicit sexual material.

SB 2150

Clarifying Abortion Law Language - SUPPORTED

Clarified, combined, and cleaned up abortion language in the Century Code. It also codified that all abortions are banned within the first six weeks of pregnancy, except in cases of rape, incest, or protecting the life of the mother.

BILLS WE SCORED IN 2023

HB 1254

Protecting Children from "Gender-Affirming" Medical **Practices - SUPPORTED**

Prohibited any health care provider from performing transgender surgeries or hormone treatments for the purpose of affirming a minor's perception of gender if it was inconsistent with the minor's biological sex. There was an exception for cases of medically documented sex development genetic disorders.

SB 2129

Alternatives-to-Abortion – SUPPORTED

Continued funding to the Alternatives-to-Abortion program, which helps promote childbirth instead of abortion and which provides services such as pregnancy testing, education, counseling, and referrals for women who are pregnant or who believe they are pregnant.

HB 1136

Religious Freedom Restoration Act – SUPPORTED

Prohibited any state or local governmental entity from impeding a person's exercise of religion unless there is a compelling governmental interest, and only if that compelling governmental interest cannot be accomplished through less restrictive means.

HB 1249

Girls' Fairness in Sports – SUPPORTED

Prohibited grade K-12 biological boys from competing in sports meant for biological girls. The bill contained a provision to still allow girls to compete on boys' teams (e.g., female field goal kicker).

HB 1522

Protections Against Preferred Pronouns and Transgender Student Accommodations – SUPPORTED

Protected government employees' free speech rights by not requiring them to use preferred gender pronouns. The bill also stated that a school may not allow students to use a restroom that does not align with their biological sex and that they may not adopt a policy that withholds information regarding a transgender student's status from their parent or guardian.
